- 1) Final Judgment and Order of Possession - to be signed by the judge if eviction is granted (*see attached*)
 - Need all blanks filled (except for move-out date, amount of money judgment and amount of supersedeas bond – these will be determined by the Judge)

- 2) Order to Withdraw Money from Court Registry (*see attached*)
 - If you are seeking any money that has been paid into the Court's Registry; complete **ONLY** if there is money deposited into the court's registry.

- 3) Court Reporter's Request for Record (*see attached*) – complete **ONLY** if you need the court reporter to write down court proceeding
 - Need name and telephone number of **all parties** appearing in front of the judge

Exhibits - any and all documents you may have to support your case ; you need to provide copies of:

- **Lease Agreement (if any)**
- **Notice to Vacate**
- **Accounting of back rent (provide ledger if any)**

YOU HAVE TO PROVIDE PAPER COPY FOR THE COURT- NOT FROM CELL PHONE & NOT FROM LAPTOP OR COMPUTER – THESE DOCUMENTS MAY BE ADMITTED INTO EVIDENCE AND WILL NOT BE RETURNED TO YOU. IF YOU NEED COPIES, GO TO THE 3RD FLOOR CLERKS' OFFICE, ROOM 300 – COST IS \$1/PAGE. LET THE COORDINATOR KNOW IF YOU LEAVE THE COURTROOM

IF YOU DO NOT HAVE THESE DOCUMENTS READY ONCE YOUR CASE IS CALLED, THE JUDGE WILL ASK YOU TO SIT DOWN AND FILL IT OUT.
