CASE SCHEDULING ORDER

The Defendant, as well as the Attorneys for the State and Defendant, are ordered to appear, unless otherwise ordered by the Court, as follows:

Arraignment (ARRG) Setting: If necessary, the Court will address probable cause, magistrate warnings, bond conditions, and other preliminary matters. If the Defendant is in custody, the Defendant will be appointed an attorney, and bail may be reviewed as appropriate. *Defendant and Defense Counsel are required to appear in person.*

Non-Trial (NTRL) Setting: (60 days from Arraignment). Court’s Standing Discovery Order *shall* be filed by this setting. *Defendant’s appearance is waived and not required to appear.* Defense Counsel may appear via Zoom.

Motions (MOTN) Setting: (60 days after NTRL). All discovery Motions are ordered to be filed with the Court by this date in accordance with the Texas Code of Criminal Procedure 28.01. *Defendant’s appearance is waived and not required to appear.* Defense Counsel may appear via Zoom.

Pre-Trial Motion (PTMO) Setting: (30 days after MOTN). All discovery and evidence exchange are ordered to be completed by this date, or this setting shall be a Discovery Hearing. Witnesses shall be subpoenaed in the absence of the evidence and ready for this setting. *Defendant’s appearance is waived and not required to appear.* Defense Counsel may appear via Zoom.

Pre-Trial Conference (PTCR) Setting: (30 days after PTMO). All Pre-Trial Intervention and Diversion application processes *shall* be completed by this date. If the case is not resolved prior to this setting and/or if the Court has not otherwise ordered, all parties shall appear at this setting to determine the status of the case. *At this time the case will be set for trial with an additional PTCR 6 days prior to trial date.* *Defendant and Defense Counsel are required to appear in person.*

Trial Setting (JTRL or CTRL): (30 days after PTCR). Jury selection is at 1:00 P.M. All parties shall report in person at 10:00 A.M. for trial. *Defendant and Defense Counsel are required to appear in person.*

Anticipated Plea: If the matter is to be disposed of by plea at any of the settings above, the plea will be *taken at the time of and in lieu of the events of that setting.* Additionally, upon agreement of both parties a setting to dispose of a case by a plea may be accelerated. *Defendant and Defense Counsel are required to appear in person.*

Additional Settings: Either party may request settings or hearings in addition to the ones listed above for good cause shown. Any additional settings must be approved by the Presiding Judge of the Court.

MAJ/MRP Settings: Motions to Revoke or Adjudicate Community Supervision will be reset for 30 days and then set for a hearing unless good cause is shown. Any additional settings must be approved by the Presiding Judge of the Court. *Defendant is required to appear.*
